j) Twin Waters West Update

Dear Resident,

And so it begins - the shifting of the goal posts and conditions of the approval are being 'tweaked'. Most concerning is the reduction of people serviced within the flood refuge from 584, to now 140 people living within the TWW site.

THIS IS JUST THE BEGINNING OF TWEAKS THAT WILL INEVITABLY FOLLOW.

We do not agree this is a Minor Change under the Act and are challenging this.

We understand some of those Councillors who voted Yes were of the understanding there would be no further changes - the application was kosher. / "experted to death" and they need to understand what they have done in progressing this application within our community.

We have notified all councillors and have spoken with DES.

This is expected from this developer, but nonetheless unacceptable.

We must encourage Council to hold fast and I encourage you all to write a quick note to ALL

councillors expressing your concerns in eroding the already inadequate conditioning of this project approval.

We have initiated questions around those other matters in relation to the conditioning and we will continue to advocate for a better outcomes.

We have requested a meeting with full council to outline various impacts remaining with the application approval and a note from individual residents will support our endeavours and we thank you in advance for please taking a moment to do so.

We need the new democratic arm of council to understand how, over 9 years, we have seen such a non-conforming application with serious impacts present be approved.

- o) Point Cartwright Care Group Inc.

The PCCG are following the New Town Plan machinations closely to ensure the findings and policy directions set out in the approved Master Plan are being considered as the Town Plan makes its way through the state interests check process. The previous submission made by PCCG to Council's town plan review team also carefully outlined the rationale for rezoning the reserve to Environment and Conservation Zone to align with the nationally significant ecology and profound cultural heritage present on the site, as well as the existing zoning of surrounding dunal areas. This correlates with the stated position of several state departments that the reserve's designation warrants review to "environmental conservation and cultural heritage purposes". Council's establishment of a temporary dog off leash area across the rocky shores continues to show a worrying lack of commitment by Council to the ecological and cultural heritage values of the site, as well as the relevant federal and state laws and policies regarding migrating shorebirds, littoral rainforest, endangered turtle nesting and cultural heritage preservation.
